Rover tickets cannot be used in the long stay car parks Smeatons Pier, St Ives / Harbour, Newquay / Moorfield, Truro. The rover ticket is not valid in any other reserved or permit spaces. All of these car parks will have signs with the Cornwall Council logo on them. The ticket does not guarantee a parking space at any time or at any location.

# EasiPermit/Permit Team Rover ticket terms and conditions

April 2018

## Rover tickets:

1. Are valid from 00.01am on the start date and finish at midnight on the expiry date as stated on the email confirmation of purchase.
2. Allow customers to park their vehicles in only the Cornwall Council long stay car parks shown on the list above.
3. Are only valid for the one vehicle registration as stated on the email confirmation of purchase. It is not transferable to other vehicles.
4. Are only issued in respect of passenger or light goods vehicles.
5. Are valid only for the days/period as stated in email confirmation of purchase.
6. Can only be used in pay and display parking bays, they are not valid in reserved or permit bays.
7. Do not guarantee a parking space at any time or at any location.
8. Remains the property of the Council and any contravention of these Terms and Conditions will render the ticket invalid.

## Car park terms and conditions

9. Ticket holders should adhere to all parking restrictions applied to any Cornwall Council car park (as displayed on notice boards) irrespective of a having a valid electronic ticket.
10. Cornwall Council accepts no liability in respect of loss or damage to any vehicle or any contents thereof unless such loss or damage is caused by the negligence of the Council.
11. Any person duly authorised by the Council may close all or any part of a car park whenever it is considered such closure is reasonably necessary. Ticket holders must not enter any Council car park once closed. Failure to comply with signs or instructions given by duly authorised personnel may result in action being taken by the Council. Refunds will only be considered on a full month basis.

## Vehicle registration changes

12. Vehicle registration changes can be made by the Permit Team. There will be a £10 administration fee for this. To request a change contact [parkingpermitenquiries@cornwall.gov.uk](mailto:parkingpermitenquiries@cornwall.gov.uk) or call 0300 1234 222. Changes to our system can take up to 3 days to process so they need to be advised in advance. NB It is not possible for temporary arrangements for you to park with the new vehicle and you will only be able to use it once it has been confirmed by the Permit Team that the new vehicle registration details have been fully processed. In emergency situations only e.g. the vehicle is stolen, the team can make arrangements for parking to be available using an existing permit.

## Refunds of a ticket

13. Refunds are only payable on Rover tickets that were purchased for a period of 7 days if we receive notification that the ticket is to be cancelled at least three working days before the date it is due to start. For longer length tickets, if it is no longer required during the period for which it has been purchased, a request for a refund can be made. Requests should be put in writing to: [parkingpermitenquiries@cornwall.gov.uk](mailto:parkingpermitenquiries@cornwall.gov.uk) or Parking Services, PO Box 664, Truro, Cornwall TR1 9DH, stating the ticket number, the name of the person who purchased the ticket and the date from which it will no longer be needed. A refund will be payable for the remaining time left on the ticket and will be made to the credit/debit card by which it was purchased. If this is not possible for any reason the refund will be made in the form of a cheque, posted to the address of the purchaser of the ticket. It can take up to 28 days to process cheques. Refunds can only be made to the person named on our records as the purchaser of the ticket.

## Renewal of a ticket

14. It is the responsibility of the ticket holder to renew a ticket in sufficient time before it expires. It is not possible for temporary arrangements to be made for parking if a ticket is not renewed in time. If the ticket has expired before a new one has been purchased then you must pay for parking.

## Penalties

15. Any breaches of the terms and conditions outlined above may result in a Penalty Charge Notice being issued.
16. Serious abuse of the system will lead to the cancellation of the ticket and would affect your ability to obtain further tickets.
17. Contravention of other parking restrictions could lead to the issue of a Penalty Charge Notice, irrespective of a valid ticket being in place.
18. The reselling of a ticket for profit is prohibited and will result in the cancellation of the ticket.

**It is an offence, under Section 115 of the Road Traffic Regulation Act 1984, for anyone to knowingly make a false statement to obtain a parking ticket for himself or any other person. It is also an offence for anyone who with intent to deceive, misuses, or lends to, or allows to be used by, any other person a parking ticket or makes or has in his possession any such thing so as to closely resemble a parking ticket which is calculated to deceive.**
