

**The Commons Act 2006**  
**Schedule 2(4)(4):**  
**Waste land of a manor**  
**not registered as common land**



Notice is hereby given that an application has been made by The Open Spaces Society to Cornwall Council as Commons Registration Authority, concerning land at Maenporth Beach described more fully below.

A summary of the effect of the application is as follows:

The land was provisionally registered as common land under section 4 of the 1965 Act; an objection was made in relation to the provisional registration; the provisional registration was referred to a Commons Commissioner under section 5 of the 1965 Act; the Commissioner determined that the land was not subject to rights of common and for that reason refused to confirm the provisional registration and the Commissioner did not consider whether the land was waste land of a manor.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by registering the land in the register of common land.

Representations:

- must state the name and postal address of the person making them, and the nature of that person's interest (if any) in any land affected by the application, and may include an e-mail address;
- must be signed by the person making them (unless sent by e-mail);
- must state the grounds on which they are made; and


