## 1. Introduction

Where new roads are built by developers the developer can enter into an agreement with the council for the road to be adopted and become a 'highway maintainable at the public expense'.

As part of these agreements plans are required to show the location of the site along with the extent of works to be undertaken and the land to be dedicated as highway and adopted by the council. In addition it may be necessary to secure legal easements over third party land to ensure that the council has sufficient rights to maintain the road in the future.

This document provides guidance for developers and designers on the plans that are required for the legal agreements and what these should contain.

## 2. General Standards

All plans submitted as part of the Technical approval process will need to include the following information

- North Point
- Scale bar
- Title block showing detailing
  - Site name
  - Drawing title
  - Drawing number
  - Designer
  - Client
  - Plan scale (including the paper size for printing)
  - Revision Block

Plans should contain the required site extent for its purpose all on one plan and not be spread across multiple sheets.

### 3. Section 38 Plan Requirements

#### 3.1. Plan A – Location Plan

This plan shows the site in relation to the surrounding area.

The plan must be taken from an up to date ordnance survey base and be of sufficient size and contain sufficient detail to enable the location of the site to be determined in relation to surrounding landmarks/development.

Plan Size	A3
Plan scale	1:1250 or 1:2500









#### 3.2. Plan B – Layout Plan

This plan shows the extent of the works to be constructed and proposed for adoption including any works on the existing highway.

The plan should include sufficient detail of the road layout and include any adoptable features within the road such as drainage, streetlights etc. The plan should also contain sufficient detail to enable the location of the road and its features to be determined in relation to the site boundary and the proposed properties, roads, paths etc adjoining it.

Plan Size	A3 to A1 (A0 may only be used where it is not possible to fit all of the site on an A1)

### 3.3. Plan C – Easement Plan







This plan shows the area required outside of the adoptable area in order for the highway authority to maintain any adoptable highway features such as drainage and streetlights.

The easements shall include for a safe and suitable access route to the asset along with sufficient working space for the maintenance and replacement of the asset. The easement plan will need to contain sufficient detail to enable the location of the easement to be determined in relation to surrounding landmarks/development.

Please note that where easements are required it is the applicant’s responsibility to ensure that these are secured in the approved format prior to the land being sold to a third party. Provisions in the transfer documents will not be accepted.

### 3.4. Plan D – Extent of Land to be Adopted by S228

This plan shows the area to be adopted under S228 of the Highways Act 1980.

The plan should contain sufficient detail to enable the location of the area to be adopted under to be determined in relation to the site boundary and the proposed properties, roads, paths etc adjoining it.

Larger size plans may be accepted up to A1 where required

## 4. Section 278 Plan Requirements

### 4.1. Plan A – Location Plan

This plan shows the site in relation to the surrounding area.

The plan must be taken from an up to date ordnance survey base and be of sufficient size and contain sufficient detail to enable the location of the site to be determined in relation to surrounding landmarks/development.

Plan Size	A3
Plan scale	1:1250 or 1:2500







### 4.2. Plan B – Extent of Highway Works

This plan shows the extent of the works to be constructed and proposed for adoption including any works beyond the existing highway which will be dedicated as highway.

The plan should include sufficient detail of the road layout and include any adoptable features within the road such as drainage, streetlights etc. The plan should also contain sufficient detail to enable the location of the road and its features to be determined in relation to the site boundary and the proposed properties, roads, paths etc adjoining it.

Plan Size	A3 to A1 (A0 may only be used where it is not possible to fit all of the site on an A1)

### 4.3. Plan C – Area to be Dedicated

Plan showing the area outside of the existing highway which is to be dedicated as new highway. The area of the adoptable area shall be clearly stated in square metres.

#### 4.4. Plan D – Easement Plan

This plan shows the area required outside of the adoptable area in order for the highway authority to maintain any adoptable highway features such as drainage and streetlights.

The easements shall include for a safe and suitable access route to the asset along with sufficient working space for the maintenance and replacement of the asset. The easement plan will need to contain sufficient detail to enable the location of the easement to be determined in relation to surrounding landmarks/development.

Please note that where easements are required it is the applicant's responsibility to ensure that these are secured in the approved format prior to the land being sold to a third party. Provisions in the transfer documents will not be accepted.
